### NCSWCD HELPING RESTORE ROYALTON RAVINE POND

Niagara County Soil and Water Conservation District is working with Smith Creek Fish Farm to clear the Royalton Ravine pond of the invasive aquatic weeds including Eurasian Watermilfoil and bladderwort that are plugging the water column and making it difficult to fish at the park. A treatment to reduce the aquatic weeds and cattails around the pond will be performed this summer to open up the water column and increase fishing access around the perimeter of the pond.

Ponds typically required periodic maintenance, and this is not the first time NCSWCD has assisted in maintaining the Royalton Ravine pond. In the summer of 2008, the Niagara County Soil and Water Conservation District provided some long overdue maintenance to the pond, including removal of the excess vegetation in and around the pond and dredging of the accumulated muck in the bottom to restore the pond to its original depth. Restoration began with the removal of trees and brush from the embankment berm. The pond was then dewatered to allow the muck to be dredged, spread out in adjacent lawn areas, dewatered, re-graded and planted with grasses to prevent erosion. During the pond dredging, the shoreline access was improved by removing the ring of cattails around the pond, although certain areas

will be allowed to revert back to provide habitat around the pond.

NCSWCD has been stocking the County Park ponds for 25 years. In addition to Royalton Ravine we have also installed and maintained aerators at Bond Lake ponds.

Funds for stocking and pond maintenance come from New Yorks State Ag & Markets Part B funds that are awarded to county conservation districts every year for conservation projects.

### ROBINSON FARMS & SMITH FARMS AWARDED 2025 DISTRICT AEM FARM AWARDS

Congratulations to this year's winners of the Niagara County SWCD AEM Farm Award, Robinson Farm of Cambria and Smith Farms of Royalton. Farms are nominated based on their efforts to implement planned Best Management Practices to protect and conserve the natural resources in the County on their own and in collaboration with the District.

Robinson Farms, a well-known fruit and vegetable farm, has been working with the District for many years to improve their impact on the environment. Projects include an the construction of an agri-chemical handling facility for storing and mixing pesticides, the annual planting of cover crops, and installation of tile drainage.

Smith Farms, formally owned and operated by Steve Smith, was the number one user of the District's inter-seeder over the past several years, planting over 450 acres of cover crops to improve soil health and maintain vegetative cover on the land through the non-growing season to reduce erosion and improve water quality. Even though the farm has been sold, Smith Farms continued to be active in protecting the soil this past year.

Winners will be presented with AEM building plaques at the Niagara County Fair Farmer's Breakfast.

No farm is too big or too small to participate in the AEM program. Please contact the office to schedule a farm visit to see how we can assist you in creating an AEM plan and future projects.

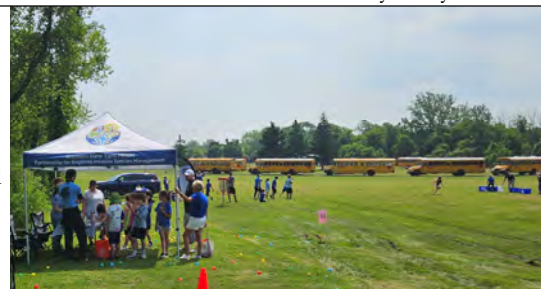

Inter-seeder rental is available for farmers to plant cover crops between corn rows. Planting can occur between v3 and v7 stage, and won't impact the corn being grown. First use of the inter-seeder is free, subsequent uses will cost \$5 per acre.



## **BUI REMOVAL PENDING AT THE EIGHTEENMILE CREEK AOC**

There will be a virtual public meeting on Tuesday, July 8, 2025, from noon to 1 p.m. to discuss restoration progress in the Eighteenmile Creek Area of Concern (AOC) in the Town of Newfane, and the proposed removal of the Degradation of Benthos Beneficial Use Impairment (BUI).

The Eighteenmile Creek AOC covers the lower creek from just below Burt Dam to Olcott Harbor. It faced water quality and sediment contamination due to past industrial, municipal, and pesticide pollution. The federal Great Lakes Restoration Initiative (GLRI) has been instrumental in providing funding to address these environmental challenges and advance the BUI removal process.

The Degradation of Benthos BUI was listed as impaired based on historical data which indicated that macroinvertebrate communities were adversely affected by contaminated sediments. Recent DEC and U.S. Geological Survey (USGS) surveys show these benthic communities are now similar or superior to those in a regional reference stream. This data satisfies BUI removal criteria and now seeks public feedback on the proposed change in designation.

The virtual meeting will provide details and criteria establishing support for the removal of the BUI. The public can download the draft report and join the meeting through the Eighteenmile Creek AOC website ([eighteenmilerap.com](http://eighteenmilerap.com)). Comments on the proposed BUI removal may be discussed during the meeting or by email at: [eighteenmilerap@gmail.com](mailto:eighteenmilerap@gmail.com) until July 30, 2025.

Niagara County Soil and Water Conservation District, in partnership with DEC and the U.S. Environmental Protection Agency, coordinates restoration efforts under the Eighteenmile Creek AOC Remedial Action Plan. A draft report, which details the completed actions and assessments supporting the BUI removal, is also available for public review at the Eighteenmile Creek AOC website.

## **Field Crews Continue to Fight Invasive Species**

Another year continues in the battle against the highly invasive Japanese knotweed. The goal of the program is to eliminate the invasive plant from Niagara County. Japanese knotweed is a major concern for displacing native species in riparian and native areas and in forests. Japanese knotweed out competes native plants and forms monocultures that displace native and more desirable species. Their lack of fine surface roots can lead to increased erosion which is problematic along waterways. Their rhizomes are capable of cracking concrete and asphalt causing costly damage to roadways, parking lots and building foundations.

Once the knotweed has been successfully eliminated, the native plants are able to grow which are utilized by native insect, bird and animal species. In addition to our existing pollinator fields at Bond Lake Park and Royalton Ravine Park, the crew has begun and will continue to create pollinator habitats of native species where knotweed patches once existed.
